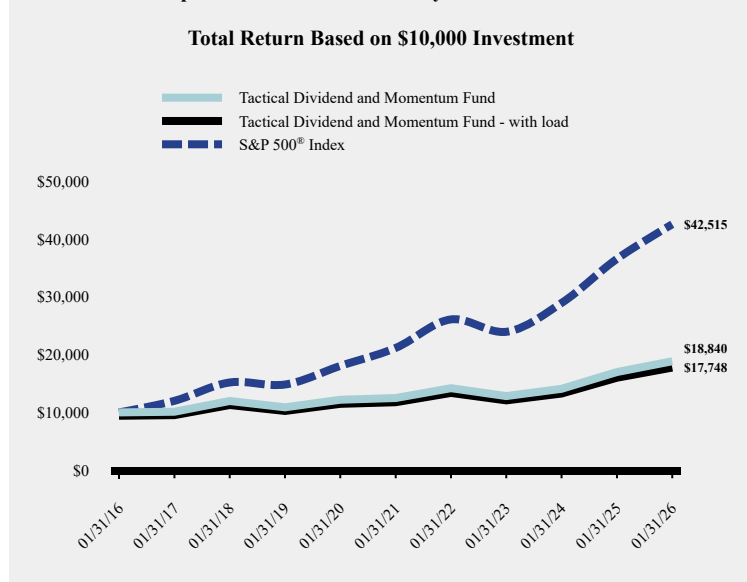
How did the Fund perform during the reporting period?

The Tactical Dividend and Momentum Fund ("the Fund") was fully invested during the semiannual reporting period (8/1/2025 – 1/31/2026). During the reporting period, Class A shares had a total return of 6.97%.

The Fund was invested in all sectors except for Healthcare and Materials at the start of the semiannual period. In December, the Fund added exposure to Materials and partial exposure to Healthcare. The decision to enter these sectors was primarily driven by tactical price-based momentum indicators.

The Fund is benchmarked against the S&P 500 Total Return Index, which returned 10.13% over the same period. As of 1/31/2026, the Fund was 97.52% invested in US equities with 2.48% in cash and equivalents.

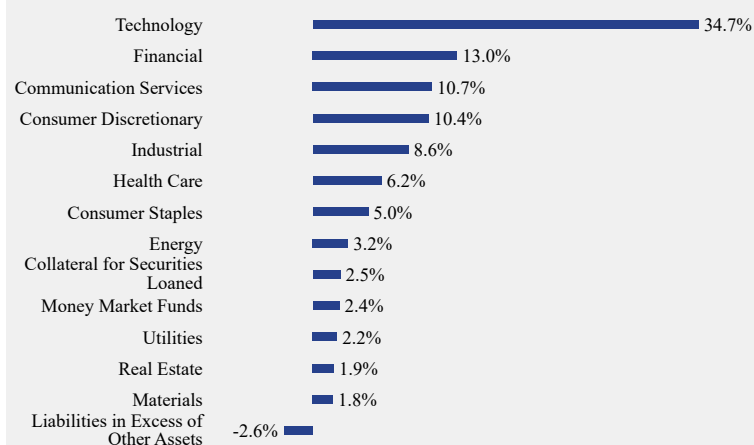

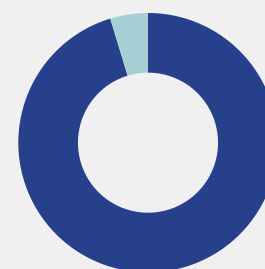
Sector Weighting (% of net assets)
